Change in Voting Process

- ▶ Due to concerns with the Covid-19 virus, voting will be change to minimize all contact.
- ▶ Identification (license) and verification of eligible voter will continue.
- ▶ The drive thru bays at Station One will be used as the voting site.
- ▶ Voting is from 7:30 to 9:00 PM.
 - ▶ Anyone still in line at 9:00 PM will be allowed to vote.

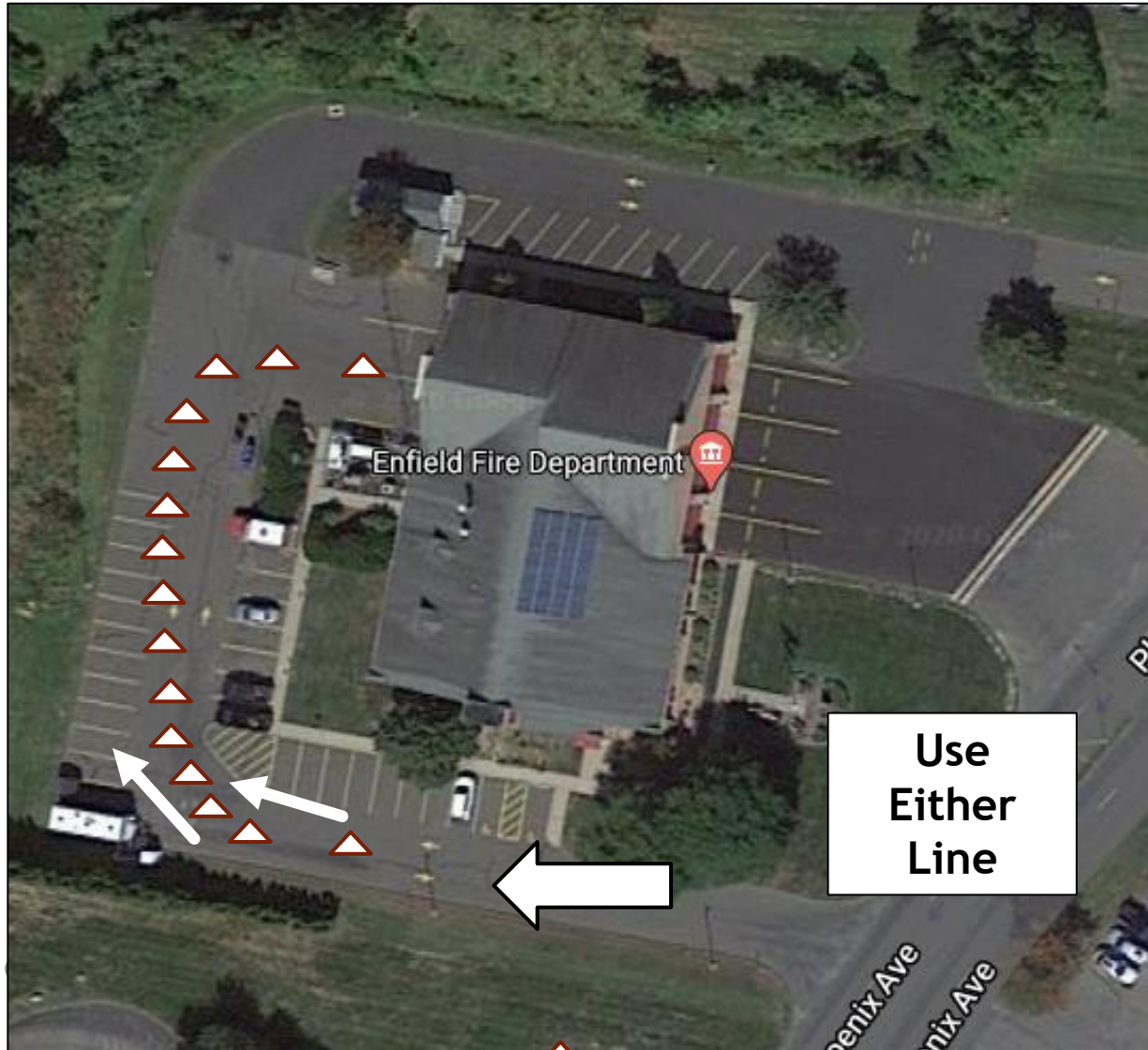
Enter via the South Driveway - 200 Phoenix Avenue (Station One)

Verification of ID

- ▶ Please bring your drivers license
- ▶ Once you drive into the Fire station Bay, you will be asked to present your license to the person that will verify your address
- ▶ Please keep your car window up
- ▶ Hold your license up to the closed window so that the person can see your name and address
- ▶ You will then roll down your window slightly to receive the ballot.
- ▶ Please pull up to the voting station
- ▶ Please indicate your vote and hand it to the person to place in the ballot box.
